The above named kennel agrees to the following statements of this contract for sale of a AKC Beagle.

The above named dog is guaranteed to be of healthy condition when sold and you have 72 hours to bring such puppy to your veterinarian for a complete health check. This puppy was given his or her needed vaccinations up to this date and the owner is required to follow up on the balance of the series of shots the puppy need to stay healthy. A full refund will be given to a buyer within the first 72 hours if the veterinarian finds this puppy is not to be in good health. The puppy must be returned to the seller within this time limit of 72 hours from the date of this contract..

This puppy is also free of any hereditary defects for three years either as a pet or show dog/pet. In this case, if the dog is found to have such a defect, than the seller will apply the full purchase price that the buyer paid for this puppy to a replacement puppy when the said seller has one available or when the buyer would like to acquire one. A hereditary healthy problem is defined as a genetic anomaly not acquired by reason of accident, injury, illness, over feeding, abuse or neglect occurring after the sale. Documentation of the puppy's condition must be provided to the seller from a qualified veterinarian. All veterinary expenses for this will be the buyer's responsibility. In the event that the buyer chooses to keep this puppy then no refund or replacement will be provided.

If for any reason, the buyer can no longer keep this puppy then, the buyer is to notify the seller and the seller will try to place the dog in an appropriate home. This dog is in no way to be given to any agency, pet store or other party without speaking to the seller first so that the seller can screen the new owner appropriately.

This dog is to be kept at all times in an environment that will enable him to grow into a stable, healthy, mature dog. A fenced (either physical or electronic) yard is strongly recommended for Beagles as Beagles tend to run away. The buyer also agrees to either tattoo or MicroChip this dog.

If this dog can no longer be kept by the buyer and a suitable new home is found by the seller, then the AKC papers must be with the dog in the new home.

Unless this dog is to be a show dog, then this dog must be neutered at six months of age and the seller will check off limited registration on the AKC papers for this dog's AKC registry. This means that this dog's offspring would not be eligible for registration if

the buyer did not neuter him/her and instead decided to breed Him. A limited registration dog that is neutered is allowed to compete in obedience trials, agility events, and other events with the exception of conformation shows.
